- *YRG Repro ensures the training, development and maintenance of the competence of all personnel within the scope of the colour quality and the production management system.*
- *YRG Repro ensures the provision of the necessary infrastructure and equipment needed for the production of compliant products.*
- *YRG Repro undertakes reviews on a regular basis of the capabilities of the infrastructure and equipment employed in the light of technological and other changes as they become available.*
- *YRG Repro ensures the policy detailed above is communicated within the business and made available all interested parties on the YRG Website for download.*


In line with the organisation's objectives and goals, the YRG Group Ltd, is committed to aligning its operations with the requirements of the following standards:
